EVENT OVERVIEW

You are cordially invited to the third VCA Rendezvous of 2005. This event, the Southwest Rendezvous, will take place in Kansas City, Kansas from June 24 to June 26 at the Kansas Speedway and Heartland Park. Four other Rendezvous are planned throughout the year at locations across the United States. All of these fantastic events are being subsidized by your National VCA Treasury to keep entry fees as low as possible.

This Southwest event is for VCA members and guests **only** and is **limited to the first 100 vehicle registrations!** The event includes autocross sessions with SRT-10 Vipers and SRT-4 Neons, drag racing, welcome reception, NASCAR ride/drive on the Speedway, charity luncheon event, pro baseball game, and banquet/award ceremony.

HOTEL REGISTRATION

The VCA host hotels are the Great Wolf Lodge (913) 299-7001 and the Hampton Inn (913) 328-1400. Please call either of the hotels directly to make your hotel reservation for Friday and Saturday nights. You must ask for a reservation under the "Viper Club Event." You can book the hotel for 1, 2 or 3 nights. The Viper-only rate at the Great Wolf Lodge is only \$189, plus tax, per night for a family suite including four (4) water park passes. The Lodge also features a full service Salon and Spa. At the Hampton Inn the Viper-only rate is \$89, plus tax, per night. The deadline for room reservations is May 24, 2005 and space is limited. Local participants are welcome to "commute," but be careful of traffic travel times.

RENDEZVOUS REGISTRATION

Once your registration form has been received and approved, you will receive an e mail confirmation that will include additional information about the event. Your registration package can be picked up Friday June 24, at the Great Wolf Lodge.

EQUIPMENT REQUIREMENTS

Please bring a helmet for the autocross. A very limited number of helmets may be available for rental, but they are on a first come, first served basis. Also, a long sleeve shirt, pants, and athletic shoes are required for the driving events. No open sandals are allowed. Driving suits will be available for those choosing to drive the NASCAR stock cars at the Speedway.
